I hereby voluntarily RELEASE, WAIVE, DISCHARGE, COVENANT NOT TO SUE AND RELINQUISH against the Base to Pickle, Inc., its officers, agents, servants or employees (herein after the "RELEASEES") from any and all actions or causes of action for personal injury, property damage, or wrongful death occurring to me as a result of my participating in the tournament WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted.

I, for myself, my heirs, executors, administrators, and assigns hereby release, waive, discharge, and relinquish any action or causes of action, aforesaid, which may hereafter arise for me and/or for my estate, and agree that under no circumstances will I or my heirs, executors, administrators, and assigns prosecute, or present any claim for personal injury, property damage or wrongful death against Base to Pickle, Inc..

I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or any loss or damage of property owned by me, as a result of being engaged in the pickleball tournament, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE. I understand that I am responsible for obtaining and pay the cost of treatment for any injuries sustained while participating in the pickleball tournament hosted by Base to Pickle, Inc..

I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs, including court costs and attorneys' fees, that they may incur due to my participation in the pickleball tournament, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise.

In the event of an injury, accident, or illness during the tournament, I authorize Base to Pickle, Inc.. and its representatives to seek and provide any necessary medical treatment or assistance on my behalf. I understand that I am solely responsible for any associated medical costs incurred.

I grant Base to Pickle, Inc. the irrevocable right and permission to use any photographs, videos, or other media captured during the tournament for promotional and marketing purposes without compensation or further approval.

I agree to abide by all the rules, regulations, and instructions set forth by Base to Pickle, Inc.. regarding the pickleball tournament. Failure to comply with these rules may result in my immediate disqualification or removal from the tournament.

I grant permission to be added to the National Pickleball League as a free member. Should I decide to pay and participate for in season competition, it will be at my own expense. No obligation exists from Base to Pickle, Inc or I to participate for agreeing to the free membership enrollment.

This waiver and release shall be governed by and construed in accordance with the laws of The State of Florida, without regard to its conflict of laws principles.
