CODE OF CONDUCT AND RELEASE OF LIABILITY WAIVER - Please read before signing:

Power Pickleball Club CODE OF CONDUCT

Welcome to Power Pickleball Club! We strive to foster a friendly, welcoming, and safe environment for all members and guests. To ensure the enjoyment and safety of everyone, we ask that all individuals adhere to the following Code of Conduct:

- 1. **Respect**: Treat all members, guests, staff, and facilities with respect. This includes refraining from disrespectful or offensive language, behavior, or gestures.
- 2. Sportsmanship: Demonstrate good sportsmanship at all times. This includes fair play, honesty, and respect for one's opponents and officials. Winning is not everything; positive participation matters.
- 3. **Safety**: Prioritize safety first. Do not play when you are injured or unwell. If playing pickleball while drinking alcohol, know your limits and play safely.
- 4. **Proper Attire:** Wear appropriate sports attire and non-marking shoes on the courts at all times. Clothing with offensive or inappropriate slogans or imagery is not allowed.
- 5. **Facility Care**: Treat the facilities with care. Do not cause any damage to the courts, nets, or any other club property. If accidental damage occurs, report it to the staff immediately.
- 6. **Responsible Alcohol Consumption:** If alcohol is consumed, do so responsibly. Alcohol is not allowed on courts during play and intoxication will not be tolerated.
- 7. **No Discrimination or Harassment**: Discrimination or harassment of any kind, including based on race, color, religion, sex, age, national origin, disability, or any other legally protected status, will not be tolerated.
- 8. **Communication:** Communicate clearly and respectfully with others. If issues arise, resolve them amicably or seek staff intervention.
- 9. **Rules and Regulations**: Comply with all rules and regulations set forth by the club, and follow any instructions given by the staff. This includes adhering to court reservations, guest policies, and membership dues.
- 10. Guests: Members are responsible for their guests' behavior and ensuring they adhere to this Code of Conduct.

Failure to follow this Code of Conduct may result in disciplinary action, up to and including the suspension or termination of your membership. If your membership is terminated due to a conduct violation no refund will be given.

By signing the membership form, you acknowledge that you have read and understood this Code of Conduct and agree to abide by it.

Power Pickleball Club RELEASE OF LIABILITY WAIVER

I, the undersigned, acknowledge that activities such as those run at Power PBC LLC (hereafter referred to as the "Power") involve risks that are both within and beyond the control of Power and that I am in proper physical condition to participate in such Activity. I further agree that if, at any time, I believe the Activity to be unsafe or potentially dangerous to myself or others, I will immediately discontinue further participation in the Activity.

1. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of others and assume full responsibility for my participation in all Activities at Power, releasing all affiliates, successors, officers,

- owners, partners, agents, successors or corporate entities (collectively known as the "Released Parties"), from any loss or damage to person or property that may be sustained as a result of participation in the Activity.
- 2. I understand that participation in Activity involves inherent and other risks including, but not limited to, risks of physical or psychological injury, pain, suffering, illness, blindness, temporary or permanent paralysis or death and I assume all risks voluntarily. As a note to these inherent risks, the use of safety glasses is recommended.
- 3. As a further condition to use of the facilities and participation in Activities, I further agree to make every reasonable effort to avoid causing or increasing the risk of injury to others, whether intentional or unintentional, by playing in appropriate clothing, using appropriate equipment and keeping my play under control at all times.
- 4. Aside from normal use wear and tear, I agree to be liable for any damage to the facility or equipment caused by willful act or negligence by me.
- 5. If medical treatment is needed as a result of my participation in the Activities, such treatment will be at my own expense, including any emergency evacuation from the facility if necessary.
- 6. This Release shall be binding upon the parties and their respective heirs, administrators, personal representatives, executors, successors and assigns. I have the authority to release the Claims and have not assigned or transferred any Claims to any other party. The provisions of this Release are severable. If any provision is held to be invalid or unenforceable, it shall not affect the validity or enforceability of any other provision. This Release constitutes the entire agreement between the parties and supersedes any prior oral or written agreements or understandings between the parties concerning the subject matter of this Release. This Release may not be altered, amended or modified, except by a written document signed by both parties. The terms of this Release shall be governed by and construed in accordance with the laws of the State of Washington.

For parents/guardians of participants of minor age: (under age of 18 at time of registation) I, the minor's parent and/or legal guardian, understand the nature of the activities and the minor's experience and capabilities and believe the minor to be qualified, in good health, and in proper physical condition to participate in such activity. I hereby release, discharge, covenant not to sue, and agree to indemnify and save and hold harmless Power & its affiliates from all liability, claims, demands, losses, or damages on the minor's account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise. Despite this release, I, the minor, or anyone on the minor's behalf makes a claim against any of the releasees named above, I will indemnify, save, and hold harmless each of the releasees from any litigation expenses, attorney fees, loss liability, damage, or cost that may incur as the result of any such claim.

I do hereby release and hold harmless the Released Parties with respect to any and all injury. I have read and fully understand the above information, warning of risk, assumption of risk and waiver/release of all claims. If registering online, my online signature or acceptance shall substitute and have the same legal effect as an original signature.
