ACCIDENT WAIVER AND RELEASE OF LIABILITY FORM

I hereby assume all of the risks participating in all & any Troublemakers Pickleball Club events, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released from dangerous or defective equipment or property owned, maintained or controlled by them, or because of possible liability without fault.

I certify that I am physically fit and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in any event held by the Troublemakers Pickleball Club.

I acknowledge that this Accident Waiver and Release of Liability Form will be used by the organizers of the Troublemakers PBC, in which I may participate and that it will govern my actions and responsibilities at said Troublemakers PBC.

I hereby acknowledge and agree that my personal information, including my email address, may be collected and used by the organizers of Troublemakers PBC in any & all events in which I am participating. I understand that this information may be used for the purposes of registration, communication, and promotion. I knowingly and voluntarily waive any legal rights I may have to restrict or limit the use of my personal information in connection with Troublemakers PBC. I understand that by participating in these events, I consent to the collection and use of my personal information as described above. I further acknowledge that the organizers of the Troublemakers PBC will take reasonable measures to protect the confidentiality and security of my personal information, but they cannot guarantee its absolute security. By signing this waiver, I release the organizers of the Troublemakers PBC from any liability related to the collection, use, or disclosure of my personal information in connection with events held by Troublemakers PBC.

In consideration of my application and permitting me to participate in this tournament, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me including my traveling to and from Hollybrook courts. THE FOLLOWING ENTITIES OR PERSONS: ALL associated with Troublemakers Pickleball Club and/or their third party agents, representatives, or volunteers.

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this tournament whether caused by negligence or otherwise.

I acknowledge that the participation in this tournament may carry with it the potential for death, serious injury, and personal loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, and lack of hydration.
