

Beach Kids Foundation Pickleball Tournament 2025 Participant Waiver and Release of Liability

Please read carefully before signing.

In consideration of being permitted to participate in the Beach Kids Foundation Pickleball Tournament 2025 ("the Event"), I, the undersigned participant (or legal guardian if under 18), acknowledge and agree to the following:

1. Assumption of Risk:

I understand that participation in pickleball involves physical activity that carries a risk of injury, including but not limited to sprains, strains, fractures, and in rare cases, serious injury or death. I voluntarily assume all risks associated with my participation or my child's participation if signing as parent or legal guardian, in the Event, whether known or unknown.

2. Release and Waiver:

I hereby release, waive, discharge, and hold harmless the Beach Kids Foundation, its board members, directors, officers, employees, volunteers, sponsors, affiliates, and agents from any and all liability, claims, demands, actions, or causes of action arising out of or related to any loss, damage, injury, or illness (including COVID-19), whether caused by the negligence of the released parties or otherwise, while participating in or attending the Event.

3. Medical Treatment:

I authorize Event organizers to secure emergency medical treatment if necessary, and I agree to be responsible for any costs incurred as a result.

4. Media Release:

I give permission to the Beach Kids Foundation to use any photos, videos, or audio recordings taken during the Event for promotional, educational, or fundraising purposes; I understand that these may include images or recordings of me (or my participating child), and I consent to their use without compensation or the need for further approval.

5. Compliance with Rules:

I agree to follow all Event rules and directions provided by staff or volunteers and understand that failure to do so may result in my (or, if signing as parent/legal guardian, my child's) removal from the Event without refund.

6. Minors:

In signing this Release on behalf of the minor child named herein, I acknowledge and agree that this Release and Waiver is intended to be binding upon both the minor and me as the parent or legal guardian. I further agree to indemnify, defend, and hold harmless

the released parties from and against any and all claims, demands, actions, causes of action, damages, losses, liabilities, costs, and expenses (including reasonable attorneys' fees and court costs) arising out of or in any way connected with the minor's participation in or attendance of the Event, whether such claims are asserted by the minor, now or in the future after reaching the age of majority, or by any other person or entity on the minor's behalf. This indemnification obligation shall apply even if the claim is based on or alleged to arise from the negligence of any released party or otherwise, and to the fullest extent permitted by law. I expressly acknowledge that this indemnification obligation is intended to survive the minor's attainment of majority and any expiration or termination of this release. By signing below, I acknowledge that I have read and fully understand this waiver and release, and that I am voluntarily giving up legal rights by signing it.
