

## NEW YEAR'S PICKLEBALL TOURNAMENT WAIVER & RELEASE OF LIABILITY

### RELEASE OF LIABILITY — READ BEFORE REGISTERING

This Release of Liability and Assumption of Risk Agreement (“Agreement”) is between the participant and Parody Pickleball Mgmt (“Organizer”), along with The Yards at Amelia, their respective owners, officers, employees, volunteers, agents, representatives, sponsors, advertisers, event partners, and facility operators (collectively, the “Releasees”).

In consideration for being allowed to participate in the New Year’s Pickleball Tournament, its related events, and all tournament activities, the participant acknowledges, understands, and agrees:

#### 1. ASSUMPTION OF RISK

Participation in pickleball involves known and unknown risks, including but not limited to slips, falls, collisions, dehydration, equipment failure, facility hazards, and actions of other participants. These risks may result in injury, serious bodily harm, permanent disability, or death. I knowingly and freely assume all risks, whether known or unknown, even if arising from the negligence of the Releasees.

#### 2. RELEASE, WAIVER, AND INDEMNIFICATION

I release, indemnify, hold harmless, and defend the Releasees from any and all claims, liabilities, damages, losses, or expenses (including attorney fees) arising from injury, disability, death, property damage, or any other harm, whether arising from negligence of the Releasees or otherwise, to the fullest extent permitted by law.

#### 3. COMPLIANCE WITH RULES

I agree to comply with all tournament rules, DUPR rules, posted facility regulations, and staff instructions.

#### 4. MEDICAL TREATMENT

I consent to emergency medical care deemed necessary and agree that Releasees assume no responsibility for related medical expenses.

#### 5. MEDIA CONSENT

I authorize Parody Pickleball Mgmt to use photos, video, or likenesses of me for marketing purposes without compensation.

6. DUPR DATA AUTHORIZATION

I authorize the submission of my match results and tournament data to DUPR.

7. PERSONAL INFORMATION

I authorize Parody Pickleball Mgmt to use my personal information for event management and DUPR submission.

8. MINOR PARTICIPANTS

A parent or guardian must sign for participants under 18.
