

**WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY  
AGREEMENT**

**READ THIS DOCUMENT CAREFULLY BEFORE SIGNING. THIS IS A RELEASE OF LIABILITY AND A CONTRACT.**

By participating in the **Rotary Club of the Mendhams Pickleball FUN~draising Tournament** (the "Event"), the undersigned participant acknowledges understanding the Event's nature and confirms they are in good health and physical condition to participate. Participants also understand that refunds are not provided for cancellations.

I, the undersigned participant, understand and agree to the following terms:

1. **Assumption of Risk:** Participants understand that athletic events like pickleball have inherent risks, including serious injury or death, which can be caused by various factors, including the negligence of those involved in the event. Participants accept all such risks and responsibility for any resulting losses or damages.
2. **Release of Liability:** Participants release the Rotary Club of the Mendhams, Rotary International, West Morris Mendham High School, West Morris Regional High School District, MD Pickleball Academy, Michele Dabal, and related entities and individuals (the "Releasees") from liability for any injury, death, or property damage, even if caused by the Releasees' negligence.
3. **Indemnification:** Participants agree to protect the Releasees from claims made by others due to the participant's actions during the Event.
4. **Medical Treatment and Expenses:** Participants consent to medical treatment if needed during the Event and are responsible for all medical costs, as the Releasees do not provide insurance.
5. **Media Release:** Participants grant permission for event organizers to use media of them from the event for promotional purposes.
6. **Code of Conduct:** Participants agree to follow event rules and behave respectfully.
