By signing below, I, the undersigned participant _____, acknowledge and agree to the following:

ASSUMPTION OF RISK

I understand that participation in pickleball and attendance at this event involve inherent risks, including but not limited to bodily injury, permanent disability, death, illness, property damage, and other losses. These risks may arise from my own actions, the actions of others, equipment, playing surfaces, weather, outdoor conditions, and/or the negligence of the event organizers or facility.

I acknowledge that **The Lab Pickleball is an outdoor facility** and that risks may include uneven or slippery courts, heat, sun exposure, dehydration, rain, lightning, insects, and changing weather conditions. I voluntarily assume all risks, known and unknown.

RELEASE & WAIVER OF LIABILITY

To the fullest extent permitted by Florida law, I hereby release, waive, and discharge **Parody Pickleball Mgmt, The Lab Pickleball**, and all associated owners, operators, employees, staff, volunteers, sponsors, agents, and affiliates (“Released Parties”) from any and all claims or liabilities arising out of my participation in or presence at the event, including claims based on negligence.

This release does not apply to gross negligence or intentional misconduct to the extent such claims cannot be waived by law.

INDEMNIFICATION

I agree to indemnify and hold harmless the Released Parties from any claims, damages, costs, or expenses (including attorneys’ fees) arising from my participation, conduct, or violation of event rules.

MEDICAL CARE

I understand that the Released Parties have no obligation to provide medical care. I authorize emergency medical treatment and transportation if deemed necessary and accept full responsibility for all associated costs.

RULES, DUPR & CONDUCT

I agree to follow all tournament rules, DUPR reporting requirements, facility policies, and staff instructions. Unsafe or disruptive conduct may result in removal from the event without refund. I authorize submission of match results to **DUPR**.

MEDIA RELEASE

I grant permission for my name, image, likeness, and voice to be photographed or recorded during the event and used for promotional or informational purposes without compensation.

PERSONAL PROPERTY

I am solely responsible for my personal belongings. The Released Parties are not responsible for lost, stolen, or damaged items.

COMMUNICABLE DISEASES

I acknowledge the risk of exposure to communicable diseases, including COVID-19, and voluntarily assume all related risks.

GOVERNING LAW

This agreement is governed by the laws of the **State of Florida**. Any dispute shall be brought exclusively in **Miami-Dade County, Florida**.

ACKNOWLEDGEMENT

I have read and understand this waiver and voluntarily agree to its terms. I understand that I am waiving important legal rights, including the right to sue.
