

**The Dink Minor League Pickleball (MiLP)
Participant Waiver, Release of Liability, Assumption of Risk, Indemnity,
and Media Release**

Acknowledgment of Risk: I understand that participation in pickleball involves physical activity and inherent risks, including but not limited to sprains, strains, fractures, concussion, head/neck/eye injuries, dehydration, heat illness, overexertion, contact with other players, equipment and playing surfaces, equipment failure and environmental hazards.

I voluntarily assume all such risks and accept responsibility for my safety during the event.

Waiver of Liability and Release: In consideration of being allowed to participate in The Dink Minor League Pickleball (MiLP), I, on behalf of myself, my heirs, assigns, and personal representatives, hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE *Pickle Crew Ph*, its officers, volunteers, and event staff; venue owners/operators (*Kingcourts Pickleball, San Fernando, Pampanga*); video and photo providers (*Sidelines/Jeric Marasigan*); livestream video providers (*Pickleton*); *The Dink Minor League Pickleball* owners, licensees, and shareholders; *DUPR* owners, licensees, and shareholders; event Sponsors; and any affiliated organizations (collectively "*Released Parties*") from any and all claims, demands, actions, or liabilities arising out of or in any way related to my participation in the event, including any claims caused by the negligence of the *Released Parties*, to the fullest extent permitted by law.

I further agree that this release includes, without limitation, injuries or damages resulting from the negligence of *Released Parties*; any equipment, facilities, or premises used during the event; participation in warm-ups, practice sessions, games, or related activities; and travel to/from the event.

Medical Treatment Consent: In the event of an emergency, I authorize the *Released Parties* to seek medical treatment for me, including first aid and emergency services, if necessary.

I authorize medical professionals to provide treatment and I agree to be responsible for all costs associated with such treatment.

Indemnification: I agree to indemnify, defend, and hold harmless the *Released Parties* from any claims, actions, damages, or liabilities arising out of my participation in the event, including claims brought by third parties arising from my conduct or actions.

Media Release (Promotions and Social Media Content): I grant Pickle Crew Ph, The Dink Minor League Pickleball (MiLP), DUPR, Sidelines/Jeric Marasigan, and Pickleton TV the exclusive, irrevocable, worldwide right to use, reproduce, publish, broadcast, distribute, and display my name, voice, statements, photographs, video, audio, likeness, and any other identifiable media (collectively, "Media") in connection with the event for marketing, promotions, social media advertising, and documentary purposes, in any format or medium now known or hereafter developed.

I understand and agree that the *Media* may be edited, altered, or reproduced at the sole discretion of *Pickle Crew Ph, The Dink Minor League Pickleball (MiLP), DUPR, Sidelines/Jeric Marasigan and Pickleton TV*, and may appear with or without my name.

I will not receive any compensation for the use of the *Media*, and I release the *Released Parties* from any claims for invasion of privacy, defamation, or misappropriation of rights in connection with the use of the *Media*.

I have voluntarily provided this consent and acknowledge that it is for promotional purposes only and may be used indefinitely, unless I revoke this consent **in writing**.

Acknowledgment and Signature I have read this waiver, fully understand its terms, and understand that I am giving up substantial rights, including my right to sue.

I acknowledge that, as Team Captain, my registration constitutes free and voluntary consent for **MYSELF AND ALL MY TEAM MATES**, and intend by my payment of the registration fees to be a complete and unconditional release of all liability.
